Hi Suzanne:

Just to keep you in the loop, I had a message from Victoria Sveinson today with respect to whether a sentencing date had been set.

After checking with Lesley (date not yet set, was remanded to September 5th date in 119), I called her back to advise there had not been a date for decision set yet, what the next remand date was and that decision would not occur there given the type of court (somewhere to "park" the matter until the Judge notifies he is ready to render his decision). I advised her further that Lesley would call her once the sentencing date was determined, which Lesley has agreed to do.

I thought it best to let you know given all the attention/press etc. about this.

I have documented this in PRISM (there is a VR file for her given her VIS, so although I previously documented my contacts with her on Robert TAMAN's VR file, I've put today's contacts with her in the "virtual file" created given the VIS), should you need the information.

tcf Robert, he had noticed I had tried calling him on his cell and was calling back. I informed him of prelim being set and provided him with the dates. We discussed him talking with the crown closer to the prelim date and I said I would call him in April to find out times he would be available. I told him what a prelim was, that it would not get media coverage, why outside council was appointed. We discussed whether he need attend. I said it was entirely up to him that it would make no difference to the judge and that he might prefer to attend the trial. Robert expressed not wanting to attend as it was just too hard for him and he didn't want to have to medicate himself to get through it. We discussed VIS and how it would be a good idea to keep a journal until he needed to have his VIS ready for court. I told Robert that there would be no court dates until the prelim but that if he had questions he could call. He said as he had no experience with court he would call if questions came up expecially as he is the information centre for the family. His in-laws are pushing for information and I said I would send him a letter advising of the prelim date and he could share that with them - he thought that would be a good idea.
